Notes for Company of Sixty Open Shoots

By returning this form and requesting to participate in the Open Shoot you are agreeing to abide by the following rules, the Rules of the NFAS, and to the DISCLAIMER which appear below and overleaf.

'Company of Sixty' means Company of Sixty Field Archers Limited, a company limited by guarantee.

1. No entries on the day will be accepted.
2. All archers must be NFAS members, and show valid membership cards on the day of the shoot. Archers may join the NFAS on the day, provided they agree to complete the NFAS application form, and pay the correct fee.
3. Maximum entry of 150 archers, on a first come first served basis.
4. By Order of the Landowner No crossbows will be permitted at any time.
5. No postal acknowledgement will be sent if your entry is accepted. If your entry is not accepted, your entry cheque will be returned to the Group Contact Name/Address supplied below.
6. Please take your rubbish home with you — this includes broken arrows etc.
7. No alcohol to be consumed during the shoot.
8. Shooting Fees: **Non-members £7, Members £2, All Juniors £2, all cubs FREE. Cheques made payable to "Company of Sixty Field Archers" please.**

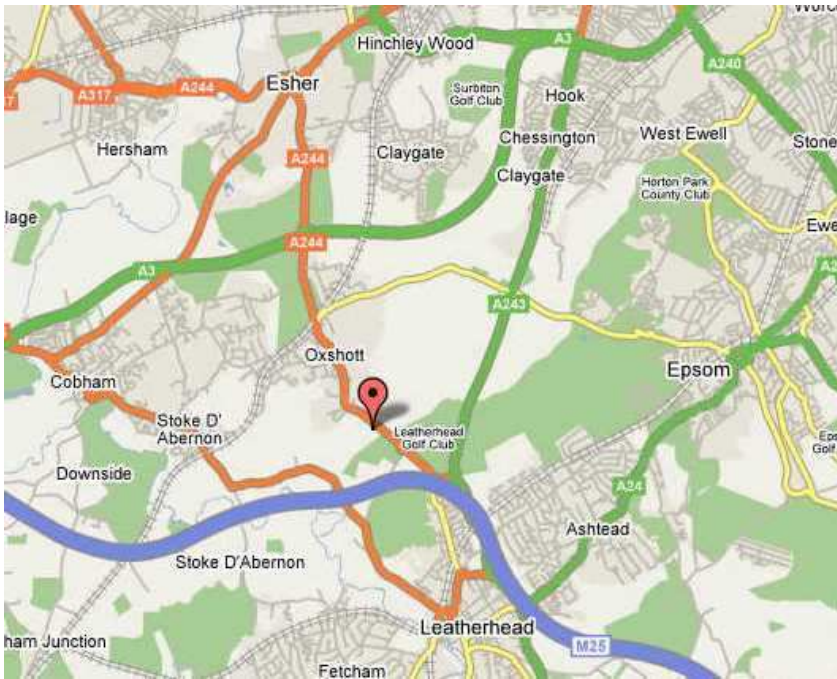

Where to find us: The shoot ground is at **OXSHOTT** in **SURREY**.

**Arriving clockwise on the M25:**

Take the M25 to J9, and exit towards Kingston and Oxshott (Surrey), on the A243 (Leatherhead bypass). At the next roundabout, take the A244, Oxshott Road, towards Oxshott. Now refer to the common part.

**Arriving anti-clockwise on the M25:**

At the roundabout, take the A244, Oxshott Road, towards Oxshott. Now refer to the common part.

**Common part:**

Follow Oxshott Road downhill to a mini roundabout, and continue straight on for approx 0.5 miles. You should see an NFAS and/or Company of Sixty sign to your left. Enter the woods via the track, and park up in a convenient spot off the trackway. Follow the track to the tea hut for registration and cards.

Notes for Company of Sixty Open Shoots (continued)

9. Child Protection statement: It is a requirement that any junior or cub shooting [or otherwise present on Company of Sixty's grounds] must be accompanied by a parent, or an adult Shoot Guardian, nominated by their parent(s), at all times. The parent/guardian will be responsible for the conduct and safety of the junior/cub at all times .
10. **DISCLAIMER**
  - a. Archery is a dangerous sport. Our open shoots take place in woodland and on uneven and muddy ground. You participate at your own risk and you have a duty to take care of your own safety and property and that of others. There is no provision for safe storage at the club and persons on our grounds must ensure that they keep their possessions with them at all times or safely secured.
  - b. To the full extent permitted by law, the Company of Sixty, its officers and agents exclude all liability for any personal injury (save in respect of personal injury or death caused by the negligence of any of the above in connection with the organisation and operation of the open shoot), and any direct or indirect loss, expense, costs, or damage howsoever caused, including by reason of any negligence on the part of any of the above.
11. Any property left at the shooting grounds which remains unclaimed after [56] days may be disposed of at the discretion of the Company of Sixty.
12. If for any reason a person's conduct appears to the shoot organiser or any responsible officer or agent of Company of Sixty in their sole discretion to be inappropriate, Company of Sixty reserves the right to refuse entry to or forthwith to remove from its grounds such person without giving any reason for so doing.
